The method of payment will be in the form of cash deposit certificate in Account No: 00181040000455 of Laxmi Bank Limited of the Patan Academy of Health Sciences (PAHS).
4. Sealed bids must be submitted to the office of Registrar, PAHS, Lagankhel, Lalitpur by hand on or before 12:00 pm, January 09, 2020. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm, January 09, 2020 at the office of Registrar, PAHS, Lagankhel, Lalitpur. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of 2.5% of Bid Amount (Inclusive of VAT), which shall be valid for 30 days beyond the validity period of the bid.
6. If the last date of purchasing and /or submission falls on a PAHS holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
